MAC FARLANE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date September 17, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of Lot 2, Section 23, Township 14 South, Range 3 West, San Bernardino Meridian, according to the United States Government Survey, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.
