MILLER Trust Dated April 14, 1969, executed in favor of The City of San Diego, bearing date August 28, 1970, conveying to said City an easement and right-of-way for water purposes, through, along and across a portion of the West Half of the Southeast Quarter of the Northeast Quarter of the Northwest Quarter of Section 23, Township 14 South, Range 3 West, San Bernardino Meridian, according to the United States Government Survey, approved May 20, 1884, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
