

RESOLUTION NO. 201830 FEB 4 1971

WHEREAS, the Air Pollution Control District for San Diego County has adopted certain rules and regulations which are intended to control the emission of pollutants into the atmosphere in San Diego County; and

WHEREAS, the present rules regulate to some degree the burning of fossil fuels with what is commonly known as "high sulfur content"; and

WHEREAS, the Air Pollution Control Officer for the County of San Diego has recommended to the Board of Supervisors that certain additional regulations concerning the use of fossil fuels be adopted which would aid in the control of not only sulfur dioxide emissions but also the control of emissions of nitrogen oxide; and

WHEREAS, the Board of Supervisors proposes to hold hearings on said recommendations on March 10, 1971; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Board of Supervisors be, and it is hereby urged to adopt as a minimum the regulations proposed by the Air Pollution Control Officer as set forth in his report of January 26, 1971.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit a certified copy of this resolution to the Board of Supervisors.
