

RESOLUTION No. 201831

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$37,494.00 by Asbury Steel Construction Company, A Corporation, for THE MODIFICATION OF MOVABLE STANDS AT THE SAN DIEGO STADIUM in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 734443.
2. That the expenditure of \$45,000.00 is hereby authorized out of the Stadium Construction Fund (950) of the City of San Diego solely and exclusively for the purpose of providing funds for THE MODIFICATION OF MOVABLE STANDS AT THE SAN DIEGO STADIUM in the City of San Diego, and related costs.



CERTIFICATION OF UNENCUMBERED BALANCE
