SUBDIVISION AND REJECTING THE OFFER OF DEDICATION FOR
PUBLIC USE THAT PORTION MARKED "RESERVED FOR FUTURE
STREET" AS SHOWN ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by BYRL D. PHELPS, Registered Civil Engineer, and entitled,
"STATE FARM SERVICE CENTER UNIT NO. 1 Being a subdivision
of a portion of Lot 45 of the partition of the Rancho Mission
of San Diego, in the City of San Diego, County of San Diego,
State of California, according to the partition Map thereof
made in an action entitled "Commercial Bank of San Diego, vs.
Juan M. Luco, et al., on file in the office of the County
Clerk of said County.", is made in the manner and form prescribed
by law and conforms to the surrounding surveys; that said map
and the subdivision of land shown thereon is hereby approved
and accepted; and said Council rejects as a dedication for
public street that portion of Lot 1 marked "Reserved for Future
Street" as shown on this map within this subdivision under the
provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,

that said Council has approved said subdivision map and that said Council rejects as a dedication for public street that portion of Lot 1 marked "Reserved for Future Street," as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
