

RESOLUTION NO. 201846 FEB 4 1971

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right-of-way for a public street and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named LOS ALTOS ROAD:

All that portion of Pacific Beach Acre Lot 6, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 791, filed in the Office of the County Recorder of San Diego County, being more particularly described as follows:


Commencing at the Southwesterly corner of Lot 1, Mc Cann Manor, according to Map thereof No. 5948, filed in the Office of the County Recorder of San Diego County; thence North 75° 59' 41" East, a distance of 50.00 feet to a point in the arc of a 172.50 foot radius curve concave Easterly, a radial to said curve bears North 72° 14' 44" West, said point being also the TRUE POINT OF BEGINNING; thence Southwesterly, Southerly and Southeasterly along the arc of said curve through a central angle of 60° 55' 14", an arc length of 183.41 feet; thence North 75° 59' 19" East, a distance of 4.16 feet; thence North 14° 00' 41" West, a distance of 174.85 feet, returning to the TRUE POINT OF BEGINNING.

The basis of bearings is the Southerly line of Lot 1, Mc Cann Manor, Map No. 5948, I. E. North 75° 59' 41" East.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby directed to file a certified copy of this resolution in

the office of the County Recorder of San Diego County.
