RESOLUTION NO. 201848 FEB 4 1971

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right-of-way for a
public street and incidents thereto, through, over, under, along
and across the hereinafter described property be, and the same
is hereby set aside and dedicated as and for a public street and
the same is hereby named SOLITA AVENUE:

All that portion of Lot 24, La Mesa Colony,
in the City of San Diego, County of San Diego,
State of California, according to Map thereof
No. 346, filed in the Office of the County
Recorder of said County of San Diego, and being
more particularly described as follows:

Beginning at the Southeasterly corner of Lot
34, Tommasa Subdivision Unit No. 2, in the
City of San Diego, County of San Diego, State
of California, according to Map thereof No.
3420, filed in the Office of the County Recorder
of said County of San Diego; thence South
88° 28' 30" West, a distance of 170.26 feet to
the beginning of a 42.00 foot radius curve
concave Northeasterly, a radial to said curve
bears South 35° 03' 20" West; thence North-
westerly and Northerly along the arc of said
curve, through a central angle of 34° 20' 18",
an arc length of 25.17 feet to the TRUE POINT
OF BEGINNING; thence South 88° 28' 30" West, a
distance of 417.23 feet to the beginning of a
12.27 foot radius curve concave Northeasterly,
a radial to said curve bears South 01° 31' 30"
East; thence Northwesterly, Northerly and North-
easterly along the arc of said curve through a
central angle of 134° 35' 00", an arc length of
28.82 feet; thence North 43° 03' 30" East, a
distance of 26.19 feet to a point of cusp in the
beginning of a 20.00 foot radius curve concave
Northeasterly, a radial to said point bears
North 46° 56' 30" West; thence Southwesterly,

Southerly and Southeasterly along the arc of said curve, through a central angle of $134^{\circ} 35' 00''$, an arc length of 46.98 feet; thence North $88^{\circ} 28' 30''$ East, a distance of 391.85 feet to a point in the arc of a 42.00 foot radius curve concave Easterly, a radial to said point bears South $77^{\circ} 10' 29''$ West; thence Southerly along the arc of said curve, through a central angle of $07^{\circ} 46' 51''$, an arc length of 5.70 feet, returning to the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.
