RESOLUTION NO. 201849 FEB 4 1971

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purpose of a right-of-way for a public street and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named CASTELAR STREET:

All that portion of Pueblo Lot 206 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which map was filed in the Office of the San Diego County Recorder as Miscellaneous Map No. 36, more particularly described as follows:

Beginning at the most Easterly corner of Lot 2, Block 2, DePuy's Subdivision according to Map thereof No. 30, recorded in the Office of the County Recorder of San Diego County on April 22, 1885; thence South 36° 07' 45" West, a distance of 71.90 feet; thence South 53° 52' 15" East, a distance of 56.00 feet to the TRUE POINT OF BEGINNING; thence South 36° 07' 45" West, a distance of 50.00 feet to a point, said point being the beginning of a tangent 20.00 foot radius curve concave Southerly; thence Northeasterly, Easterly and Southeasterly along the arc of said curve, through a central angle of 90° 00' 00", an arc length of 31.42 feet; thence South 53° 52' 15" East, a distance of 152.27 feet; thence North 21° 12' 35" West, a distance of 204.63 feet; thence South 36° 07' 45" West, a distance of 80.43 feet, returning to the TRUE POINT OF BEGINNING.

The basis of bearings = the centerline of Soto Street as shown per map of Valeta Knolls, Map No. 3716, I. E. North 36° 07' 45" East.
