

RESOLUTION NO. 201850 FEB 4 1971

WHEREAS, The City of San Diego is the owner of certain rights to enter upon privately-owned property to remove grass, weeds, rubbish and to excavate the natural channel of Chollas Creek in portions of Lots 33 through 39, W. T. Lemon's Subdivision, and portions of Lots 50 and 51, Block 2, of J. R. Spencer's Subdivision; and

WHEREAS, the owners of the property have requested that the City release to them all of the City's interest in and to said rights; and

WHEREAS, said rights were acquired in connection with a natural drainage channel and are no longer needed since the Chollas Creek Channel has been placed in service; and

WHEREAS, the City Engineer and the Public Works Director have no objection to the releasing of these rights; and

WHEREAS, a fee of \$35.00 has been collected to cover the processing of this request; and

WHEREAS, the release of the aforementioned property rights is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That those certain real property rights described in that form of Release of Rights, on file in the office of the City Clerk as Document No. 734797, be, and the same are hereby released to THE OWNERS IN FEE SIMPLE OF RECORD of Lots 33 through 39, W. T. Lemon's Subdivision, and Lots 50


and 51, Block 2, of J. R. Spencer's Subdivision.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Release of Rights, the form of which is on file in the office of the City Clerk as Document No. 734797, releasing and relinquishing to THE OWNERS IN FEE SIMPLE OF RECORD of Lots 33 through 39, W. T. Lemon's Subdivision, and Lots 50 and 51, Block 2, of J. R. Spencer's Subdivision, certain rights to remove grass, weeds, rubbish and to excavate the natural channel of Chollas Creek, across portions of Lots 33 through 39, W. T. Lemon's Subdivision, and portions of Lots 50 and 51, Block 2, of J. R. Spencer's Subdivision, as more particularly described in said form of Release of Rights.

3. That the City Clerk of said City is hereby authorized and directed to deliver said Release of Rights to the Property Director for further handling.
