1. That the bid of \$6,842.00 by World Wide Painting Services, Inc. dba Marine & Industrial Coatings Company, a corporation, for the CLEANING AND SANDBLASTING THE INSIDE OF THE WASH WATER TANK AT THE MIRAMAR FILTER PLANT, AND RECOATING WITH COAL TAR ENAMEL in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 734280.

That the expenditure of \$8,126.00 is hereby authorized out of the Water Utility Operating Fund 500 of the City of San Diego solely and exclusively for the purpose of providing funds for CLEANING AND SANDBLASTING THE INSIDE OF THE WASH WATER TANK AT THE MIRAMAR FILTER PLANT, AND RECOATING WITH COAL TAR ENAMEL in the City of San Diego, and related costs.
