BE IT FURTHER RESOLVED, that VISION DRIVE, between a point approximately 260 feet westerly of Easter Way and the westerly terminus,

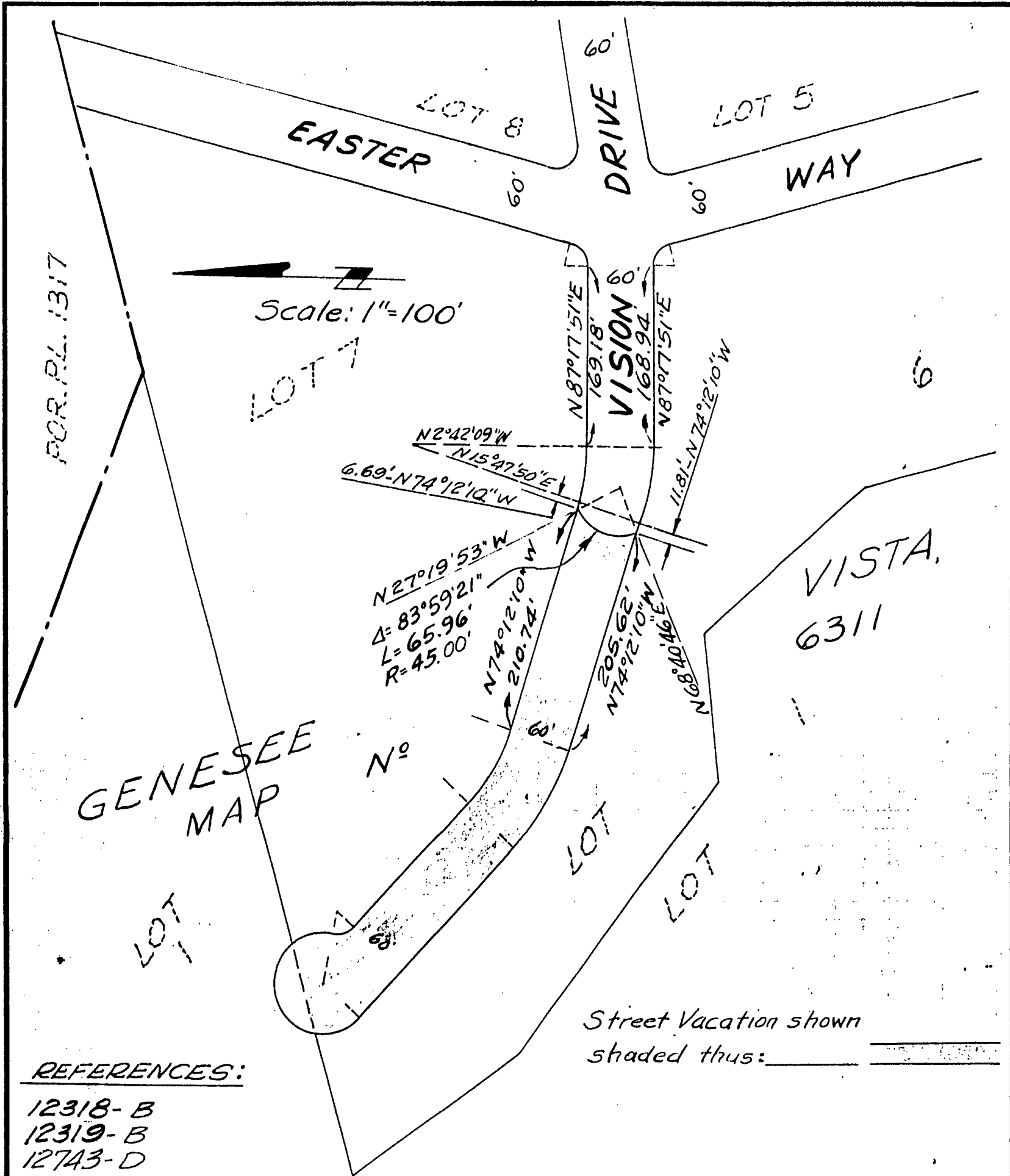
