

RESOLUTION No. 201902

Adopted on FEB 16 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Shell Oil Company 2. Atlantic Richfield Company 3. Pepper Oil Company, Inc. 4. Standard Oil Company of California, Western Operations, Inc. (A Division of Standard Oil Company of California) and 5. Union Oil Company of California are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS PETROLEUM PRODUCTS, INCLUDING GASOLINE, DIESEL OIL, FUEL OIL, KEROSENE AND LUBRICATING OILS AND GREASES as may be required for the period of one year beginning February 16, 1971 through February 15, 1972, per prices on file in the Purchasing Department, as follows:

1. Shell Oil Company for Section I, Regular and Ethyl Gasolines delivered to various locations; terms net 30 days, and;
2. Atlantic Richfield Company for Section II, Item 1, Diesel Oil; terms net 30 days, and;
3. Pepper Oil Company, Inc. for Section II, Item 2, Fuel Oil; terms $\frac{1}{4}$ of 1% 20 days, and;
4. Standard Oil Company of California, Western Operations, Inc. (A Division of Standard Oil Company of California) for Section II, Items 3 and 4, Kerosene; terms net 30 days, and;
5. Union Oil Company of California for Section III - Lubricating Oils and Greases; terms net 30 days.


