

RESOLUTION NO. 201910 FEB 16 1971

APPROVING MAP OF UNIVERSITY VILLAGE UNIT NO. 8
AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC
STREETS AND PORTION OF PUBLIC STREET DEDICATED ON
SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by THOMAS E. CRAIG, Registered Civil Engineer, and entitled,
"UNIVERSITY VILLAGE UNIT NO. 8 Being a subdivision of
portions of Pueblo Lots 1276 and 1277, in the City of San Diego,
County of San Diego, State of California, according to Map
thereof made by James Pascoe in 1870, a copy of which Map was
filed in the office of the County Recorder of San Diego County
and known as Miscellaneous Map No. 36.", is made in the manner
and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown thereon
is hereby approved and accepted; and said Council hereby accepts
on behalf of the public the public streets and portion of public
street, to wit: Pauling Avenue, Cather Avenue, Weller Street
and a portion of Lipmann Street for public purposes, and said
streets and portion of street are hereby declared to be
public streets and portion of public street and dedicated to
the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
