VACATION OF YUMA STREET.

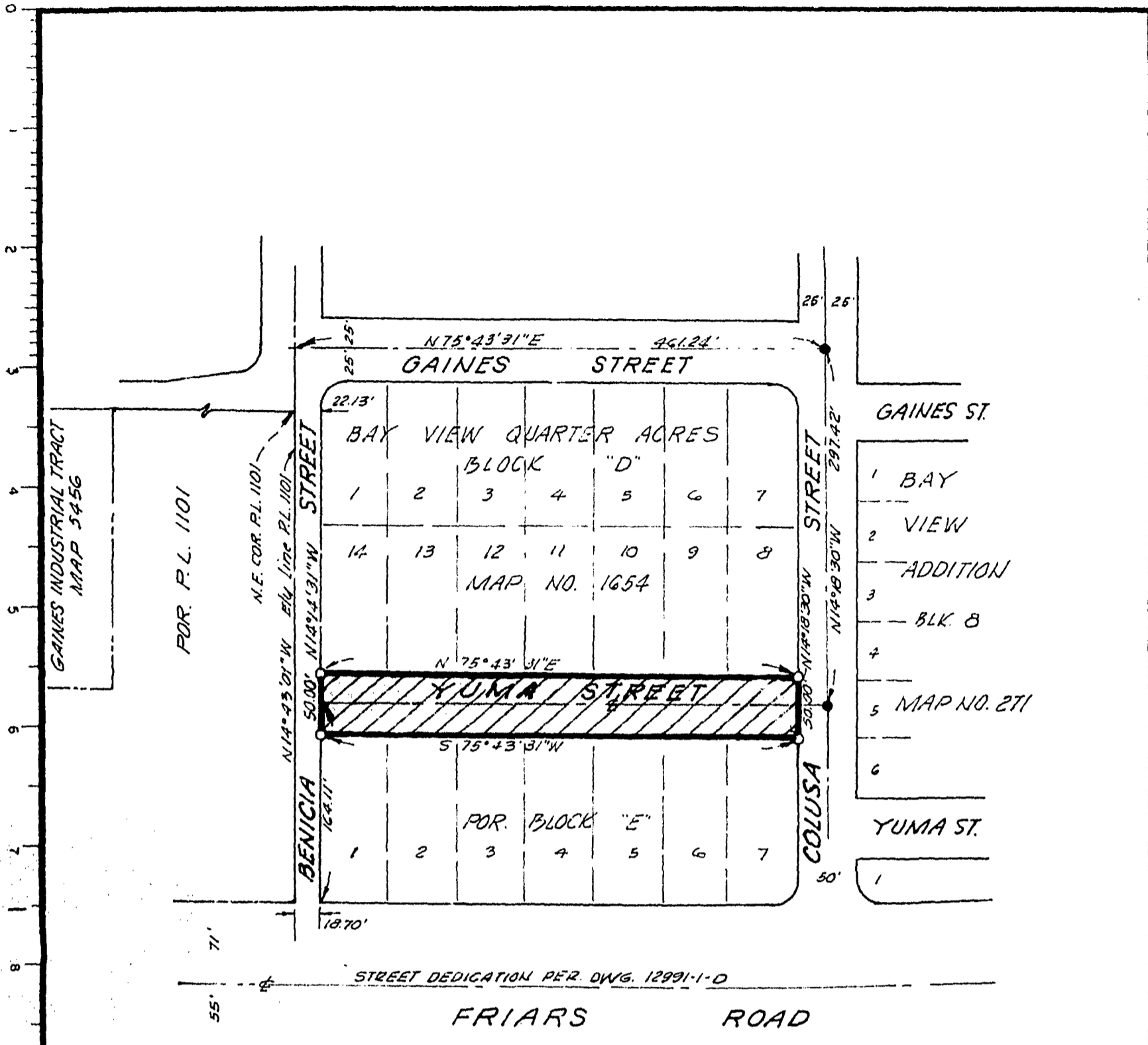
BE IT RESOLVED, By the Council of The City of San Diego,

Benicia Street and Colusa Street,

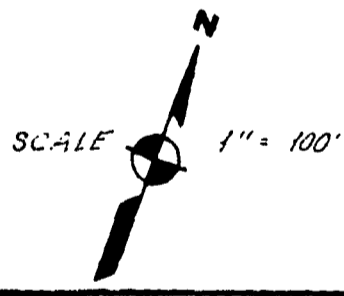
as more particularly shown on Map No. 12375-B, on file in the
