APPROVING MAP OF COLUSA PARK AND ACCEPTING ON BEHALF OF THE PUBLIC THE PORTION OF PUBLIC STREET DEDICATED ON SAID MAP AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "COLUSA PARK Being a subdivision of portions of Lots 1 through 7 and all of Lots 8 through 14 of Block D, and portions of Lots 1 through 7 of Block E, together with that portion of Yuma Street as vacated, in Bay View Quarter Acres, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1654 recorded in the office of the County Recorder of said San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portion of public street, to wit: portion of Colusa Street for public purposes and said portion of street is hereby declared to be portion of public street and dedicated to the public use.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
