

RESOLUTION No. 201971

Adopted on FEB 23 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Lease Agreement with BILLY R. JONES and BOBBY J. JONES dba FLYING J AVIATION, leasing Buildings Nos. 4, 7 and 55, together with aircraft tiedown ramp area of 106,190 square feet and vacant land area of 9,000 square feet at Brown Field, for a term of two (2) years ending January 31, 1973, at a minimum annual rental of \$6,500 for the first year and \$7,500.00 for the second year, or a sum of percentages of gross income, whichever is greater, for the purpose of engaging in the business of aircraft engine and airframe repairs, sales and renting of aircraft, aircraft parts and accessories, flight instruction, renting aircraft storage and tiedown space, operating an aircraft charter and flight service, and sale of aviation petroleum products to the general public, under the terms and conditions set forth in the form of Lease Agreement, on file in the office of the City Clerk as Document No. 734960.
