<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Carmelinda A. Wood	PUBLIC WORKS DEPARTMENT Equipment Division	\$15	The suggester proposed a single six-part NCR form to replace 3 different forms made by cutting paper specially and using carbon. Estimated saving in clerical time, \$157 per year.
Alfred R. Gagnon	PUBLIC WORKS DEPARTMENT Street Division	\$15	The use of an opening with a gate in it in the tailgates of dump trucks used for distributing asphalt to cover trenches was proposed. This has been done on at least five trucks at this time. The saving is indeterminate, but the gates do improve the operation.
Ivan D. Lewis	PUBLIC WORKS DEPARTMENT Equipment Division	\$10	A better, time-saving way to handle boxes of scrap material was suggested. A saving of \$87 per year in time was estimated.
Robert D. Peters	WATER UTILITIES DEPARTMENT	\$10	It was suggested that micro-film cards be used for subdivision maps instead of photo-copies. A \$90 per year saving in photos is estimated.
