

RESOLUTION NO. 201981

WHEREAS, an appeal was filed by Nelson Brav as attorney for Wilbur H. Hallett, Jr. from a decision of the Chief of Police in denying a taxicab driver's permit, pursuant to San Diego Municipal Code, Section 72.06(g)(6), which decision, pursuant to notice and hearing, was based on the fact that Mr. Hallett is currently on probation for annoying or molesting a child (violation of California Penal Code, Section 647a) and is currently registered as a sex offender under provision of the California Penal Code, Section 290, indicating his unfitness to drive a taxicab, and all of which is more fully set forth in Document No. 735221 on file in the office of the City Clerk; and

WHEREAS, Mr. Hallett was notified by the City Clerk that the City Council would hear this appeal at its regular meeting on the 4th day of February 1971; and

WHEREAS, it was the decision of the Council to continue the appeal to the 25th day of February 1971; and

WHEREAS, it was the decision of the Council to deny the appeal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the appeal of Wilbur H. Hallett, Jr. by his attorney Nelson Brav is denied, and a taxicab driver's permit shall be issued, as recommended by the Chief of Police.
