OF PUBLIC STREET DEDICATED ON SAID MAP
WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "GOLDEN VALLEY UNIT NO. 2 Being a subdivision of a portion of Lot 5 of the partition of Pueblo Lot 1105, in the City of San Diego, County of San Diego, State of California, according to Referree's Map thereof made in that certain action entitled 'Thomas J. Daley vs. Arpad Haraszthy, et al.', being Numbered 1029 in the Superior Court of California in and for the County of San Diego, which said Map is filed in the office of the County Clerk of said San Diego County, and portions of Lots 9 and 12, of E. W. Morse's Subdivision of the West half of Pueblo Lot 1106, according to Map thereof No. 103 filed in the office of County Recorder of San Diego County, November 6, 1885.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portion of a public street, to wit: portion of Hotel Circle, for public purposes, and said portion of street is hereby declared to be portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
