

RESOLUTION NO. 201989 FEB 25 1971

APPROVING MAP OF HIDDEN VALLEY AND ACCEPTING  
ON BEHALF OF THE PUBLIC THE PORTION OF PUBLIC  
STREET DEDICATED ON SAID MAP, AND ACCEPTING  
ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENTS  
GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by W. R. NOTHOMB, Licensed Land Surveyor, and entitled,  
"HIDDEN VALLEY Being a subdivision of a portion of Lot 1288  
of the Pueblo Lands of San Diego, in the City of San Diego,  
County of San Diego, State of California, according to the  
Map thereof made by James Pascoe in 1870, a copy of which said  
Map was filed in the office of the Recorder of San Diego  
County, November 14, 1921 and is known as Miscellaneous Map  
No. 36.", is made in the manner and form prescribed by law and  
conforms to the surrounding surveys; that said map and the  
subdivision of land shown thereon is hereby approved and accepted;  
and said Council hereby accepts on behalf of the public, the  
portion of public street, to wit: portion of Ardath Road,  
for public purposes and said portion of a street is hereby  
declared to be portion of a public street and dedicated to  
the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego those easements shown on Sheet 2 of this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and that those certain easements as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
