BE IT FURTHER RESOLVED, that the Project budget in the amount of \$260,292 is hereby approved and the expenditure of \$260,292 is hereby authorized out of Model Cities First Action Year Fund 2901 of The City of San Diego, solely and exclusively for the purpose of providing funds for the operation of said Project.
