WHEREAS, the Clairemont Recreation Council has generously offered to contribute to The City of San Diego the sum of \$250 for the purpose of purchasing an electric basketball scoreboard for the North Clairemont Park and Recreation Center;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$250 from the Clairemont Recreation Council and directs that said contribution be deposited in Capital Outlay Fund 245 and thereafter to be matched by an additional \$250 from The City of San Diego to be used exclusively for the purpose of purchasing an electric basketball scoreboard for the North Clairemont Park and Recreation Center.

2. That the expenditure of \$500 from Capital Outlay Fund 245 is hereby authorized solely and exclusively for the purchase of an electric basketball scoreboard for the North Clairemont Park and Recreation Center.

3. That this Council does hereby commend the Clairemont Recreation Council for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the Clairemont Recreation Council.
