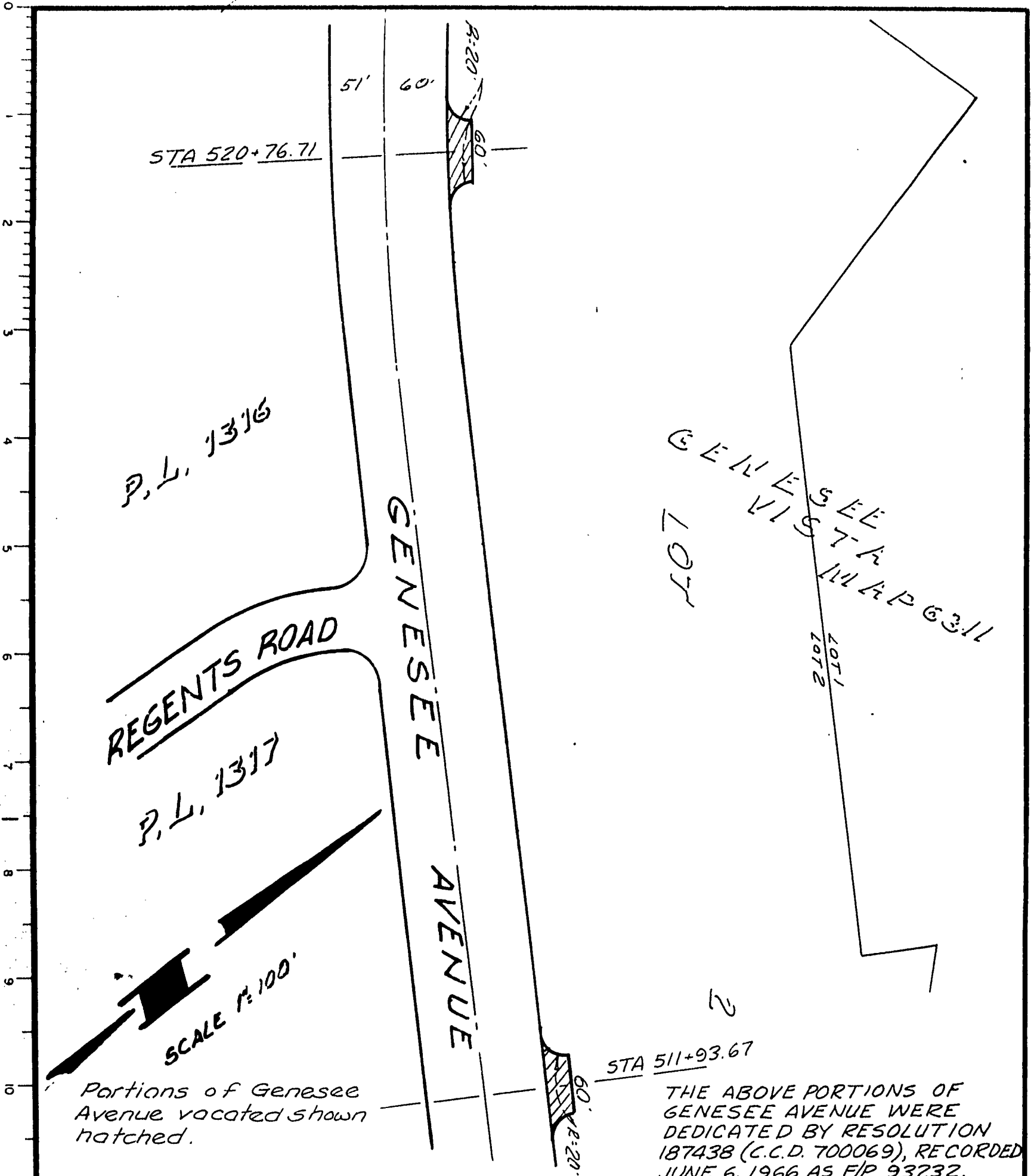
as more particularly referred to in Resolution of Intention No. 201877 is unnecessary for present or prospective public street purposes.
