Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "THE KNOLLS OF DEL CERRO UNIT NO. 1 Being a subdivision of a portion of Lot "F" of the Partition of a portion of Lot 70 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made in Action No. 15191 of the Superior Court of San Diego, entitled 'San Diego Realty Company vs. Maria Y. Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
