

RESOLUTION NO. 202035 MAR 2 1971

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by city council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of a street reservation in Lot 55 of Horton's Purchase, more particularly described as a reservation of an easterly extension of T STREET from 47th Street to 48th Street, and a westerly portion of 48TH STREET between T Street and Ocean View Boulevard, has been relocated through the approval and dedication on this date of a portion of T STREET, as more particularly shown on Drawing No. 14046-D, on file in the office of the City Clerk as Document No. 735042; and

WHEREAS, those properties adjoining that portion of the aforesaid street reservation to be vacated will continue to have access or will be accessible by the alternate route dedicated on this date; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a street reservation in Lot 55, Horton's Purchase, as more particularly shown on Drawing No. 14602-D, on file in the office of the City Clerk as Document No. 735030, which said drawing is attached hereto and made a part hereof be, and the same is hereby vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

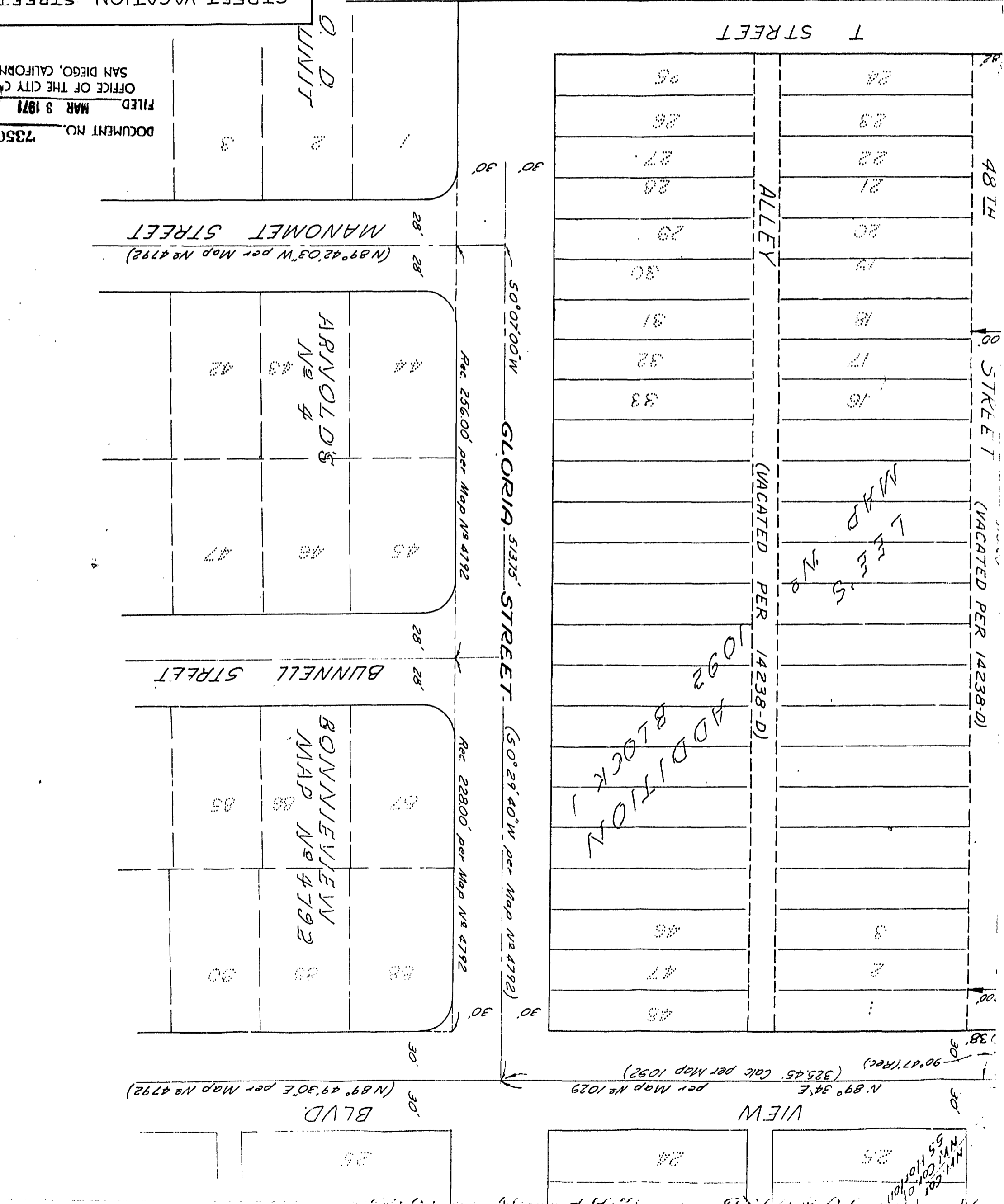
