RESOLUTION No. 202055

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of VELMA JOHNSON, a widow, executed in favor of The City of San Diego, bearing date February 1, 1971, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 16 in Block 1 of Panama Heights, according to Map thereof No. 1251, filed in the Office of the County Recorder of San Diego County, together with an easement for slope purposes, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 40th STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
