

RESOLUTION NO. 202073 MAR 2 1971

WHEREAS, GOODALL'S CHARTER BUS SERVICE, INC., a California corporation, has applied to the City Council for a Certificate of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) There is a demand of the public for automobiles for hire of the type proposed in the application of Goodall's Charter Bus Service, Inc.;

(b) Existing public transportation is inadequate for the accomplishment of the purposes stated in the application;

(c) The applicant is financially responsible and experienced;

(d) The equipment applicant proposes to use in the performance of the services proposed in the application consists of two Checker Aerbus Limousine/Buses;


(e) The additional service for automobile for hire posed by applicant will not result in any greater traffic congestion or hazard to the public; and

WHEREAS, the City Council on this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That GOODALL'S CHARTER BUS SERVICE, INC., 5173 Baltimore Drive, La Mesa, California, having filed an application for a Certificate of Public Convenience and Necessity to operate two vehicles for hire pursuant to the provisions of Section 72.11 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, a Certificate of Public Convenience and Necessity is hereby granted to GOODALL'S CHARTER BUS SERVICE, INC. to operate the vehicles specified in the application for a two-year period of time, expiring March 1, 1973, subject to compliance with all provisions of the San Diego Municipal Code.
