

RESOLUTION NO. 202089 MAR 4 1971

A RESOLUTION REGARDING THE OPERATION  
OF THE SAN DIEGO MODEL CITIES RELOCATION  
PROGRAM PROJECT BY THE COMMUNITY DEVELOP-  
MENT DEPARTMENT OF THE CITY OF SAN DIEGO.

WHEREAS, The City of San Diego, California, has entered into a contract with the Department of Housing and Urban Development of the United States of America for a grant to carry out, within the City of San Diego, a Model Cities Program; and

WHEREAS, the Comprehensive Demonstration Plan authorized by Resolution No. 199764 of the San Diego City Council was approved by HUD and designates The City of San Diego as the operating agency for the Relocation Program Project; and

WHEREAS, the Grant Agreement for Program No. ME-04-005 provides Model Cities supplemental funds for the operation of said Project and requires that the City develop a Relocation Program in accordance with HUD guidelines; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Relocation Program which is attached as Exhibit E to the agreement on file in the office of the City Clerk as Document No. 735148, be and it is hereby approved.

BE IT FURTHER RESOLVED, that The City of San Diego, operating through its Community Development Department under the direction of the City Manager hereby assumes full responsibility for the implementation and operation of the Relocation Program Project which will effect the Relocation Program.

BE IT FURTHER RESOLVED, that to the extent permitted by law and its Charter, the City shall operate said Project in accordance with the terms and conditions specified in the Operating Agency Agreement as modified by additions and interlineations and in accordance with the attachments thereto, which together with said agreement are on file in the office of the City Clerk as Document No. 735148.

BE IT FURTHER RESOLVED, that the Project budget in the amount of \$59,031 is hereby approved and the expenditure of \$59,031 is hereby authorized out of Model Cities First Action Year Fund 2901 of The City of San Diego, solely and exclusively for the purpose of providing funds for the operation of said Project.
