BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the revised schedule set forth below for compensation to members of the Model Cities Citizens Policy Committee (CPC) for their attendance at regularly scheduled meetings and activities be and it is hereby approved:

Task Force, Standing, Executive Committee Meetings	\$10.00
CPC General Meetings	\$15.00

BE IT FURTHER RESOLVED, that the maximum amount which may be accrued under said schedule be increased from \$45.00 to \$60.00 per month.

BE IT FURTHER RESOLVED, that in addition to the compensation provided by the revised schedule above, CPC members may be compensated for their participation in occasional special activities at a rate of \$10.00 for each such activity. Such additional stipends must be authorized in advance by the Citizens Policy Committee and the Model Cities Director.

BE IT FURTHER RESOLVED, that Resolution No. 201721, adopted January 26, 1971, is hereby rescinded.
