

RESOLUTION NO. 202097 MAR 9 1971

WHEREAS, the U. S. Army Corps of Engineers has indicated that the extension of the south jetty as part of the San Diego River and Mission Bay California Flood Control Project beyond its present position is not presently necessary; and

WHEREAS, the U. S. Army Corps of Engineers has indicated that the present sand bar across the mouth of the San Diego River will not be a significant danger during flood conditions if no larger than the below mentioned dimensions; and

WHEREAS, the present sand bar extending across the mouth of said San Diego River at the above south jetty is being used by the public for recreational purposes and ecological study; and

WHEREAS, it is desirable to refrain from materially disturbing said above-mentioned sand bar; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The City of San Diego will refrain from initiating any extension of the south jetty as part of the San Diego River and Mission Bay California Flood Control Project beyond its present location; and

2. The City of San Diego will not disturb the above mentioned sand bar except to clean the beaches thereof,

and prevent sand buildup which is dangerous to the surrounding community, said prevention of sand buildup not to diminish said sand bar to less than approximately 150 feet in width with an elevation of approximately 12 feet above the mean low tide line, approximately 300 feet in width at normal high water elevation and approximately 600 feet in width at normal low water elevation.

3. The City of San Diego will request the United States Army Corps of Engineers to place sand dredged from the San Diego River channel onto the above mentioned sand bar in order to obtain an approximate elevation of 12 feet above the mean low tide line with a width of 150 feet.
