

RESOLUTION No. 202101

Adopted on MAR 9 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$10,184.00 by Pacific Sign Construction, A Partnership, for the CONSTRUCTION OF AN ILLUMINATED OVERHEAD SIGN WITH GATES AT THE BUSINESS ENTRANCE OF THE SAN DIEGO STADIUM in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 734642.
2. That the expenditure of \$11,000.00 is hereby authorized out of the Stadium Construction Fund (950) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF AN ILLUMINATED OVERHEAD SIGN WITH GATES AT THE BUSINESS ENTRANCE OF THE SAN DIEGO STADIUM in the City of San Diego, and related costs.


