That the expenditure of \$28,080.00 is hereby authorized out of Capital Outlay Fund 245, and \$4,625.00 is hereby authorized out of Park and Recreation Bond Fund 725, for a total amount of \$32,705.00, solely and exclusively for the purpose of providing funds for the City's contribution toward the cost of the improvement of SIXTH AVENUE, between Elm Street and Upas Street, under the 1911 Act proceedings.
