

RESOLUTION NO. 202136 MAR 11 1971

APPROVING MAP OF WESTY PARK UNIT NO. 2 AND  
ACCEPTING ON BEHALF OF THE PUBLIC THE PORTION OF  
PUBLIC STREET DEDICATED ON SAID MAP AND ACCEPTING  
ON BEHALF OF THE CITY OF SAN DIEGO CERTAIN ABUTTERS'  
RIGHTS OF ACCESS AS GRANTED ON THIS MAP WITHIN THIS  
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by BYRL. D. PHELPS, Registered Civil Engineer, and entitled,  
"WESTY PARK UNIT NO. 2 Being a subdivision of portions of  
Lots 1 to 6 inclusive and 19 to 24 inclusive, Block "J" Imperial  
Beach Gardens, in the City of San Diego, County of San Diego,  
State of California, according to Map thereof No. 1978, filed in  
the office of County Recorder of San Diego Sounty, December 28,  
1926.", is made in the manner and form prescribed by law and  
conforms to the surrounding surveys; that said map and the  
subdivision of land shown thereon is hereby approved and accepted;  
and said Council hereby accepts on behalf of the public, the  
portion of public street, to wit: portion of 19th Street for  
public purposes and said portion of street is hereby declared  
to be portion of public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council accepts on behalf  
of The City of San Diego, a municipal corporation, any and all  
abutters' rights of access in and to Dahlia Avenue, adjacent

and contiguous to Lot 2, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
