

RESOLUTION NO. 202157 MAR 16 1971

APPROVING MAP OF LA JOLLA VISTA TOWNHOUSES
SUBDIVISION AND ACCEPTING ON BEHALF OF THE
CITY OF SAN DIEGO THE EASEMENTS AND CERTAIN
ABUTTERS' RIGHTS OF ACCESS GRANTED ON THIS
MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by ROBERT E. YOUNG, Registered Civil Engineer, and entitled,
"LA JOLLA VISTA TOWNHOUSES Being a subdivision of a portion
of Lot 2 of Genesee Vista, in the City of San Diego, County of
San Diego, State of California, according to Map thereof No. 6311
filed in the office of the County Recorder February 27, 1969,
and a portion of Genesee Avenue, vacated to public use.", is
made in the manner and form prescribed by law and conforms to
the surrounding surveys; that said map and the subdivision of
land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, the
easements for open space as granted and shown on said map, and
subject to the conditions set forth thereon.

Said Council hereby accepts on behalf of The City of San
Diego, a municipal corporation, any and all abutters' rights of
access in and to Genesee Avenue, adjacent and contiguous to Lots
47-C, 48-D, 49-E, 50-F, and 51-G, all as granted and shown on
said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map as and for the act of the Council that said Council has approved said subdivision map and that those certain easements for open space, together with the abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
