That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with VICTOR WULFF AND ASSOCIATES, A.I.A., architects, for architectural and engineering services in connection with improvements to the Lawn Bowling Club and the Morley Field Shuffleboard Club in Balboa Park, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 735301.

BE IT FURTHER RESOLVED, that the expenditure of \$8,000 is hereby authorized out of Park and Recreation Bond Fund 725, solely and exclusively for the purpose of providing funds for the architectural and engineering services described above.
