Carol L. Parker	LIBRARY	\$50	The accessibility of college catalogues has been greatly improved, saving about \$500 a year in time and also improves service.
Willard S. Paulson	PARKS & PUBLIC BLDGS. Bldgs. & Facilities Div.	\$30	The design for rebuilding of folding tables by the suggester will save about \$300 a year in maintenance, and their life will be increased.
Thomas J. Olson	PUBLIC WORKS Equipment Division	\$20	The suggester found a more economical make of oil filter for special engines. This will save about \$200 a year in the cost of filters.
Frank M. Erwin, Jr.	PUBLIC WORKS Communication Division	\$15	The suggester proposed a file that will save the time of Electronic Technicians in locating information in regard to maintenance jobs. This amounts to \$146 per year.
Frank M. Erwin, Jr.	PUBLIC WORKS Communication Division	\$10	The suggested method of eliminating a problem with sirens has saved \$112 in the past year.
