

# RESOLUTION No. 202214

Adopted on MAR 23 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SIDNEY JAFFE and GLADYS M. JAFFE, husband and wife; ALLEN JAFFE and BERNITA JAFFE, husband and wife; and LAWRENCE JAFFE and EUGENIA A. JAFFE, husband and wife, executed in favor of The City of San Diego, bearing date November 13, 1970, conveying to said City an easement and right of way for street purposes through, over and across portions of San Carlos Unit No. 10 according to map thereof Number 5294 filed in the office of the County Recorder of said County, together with an easement for sewer purposes, as more particularly described in said deed, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named LYNNHAVEN LANE, and the land therein conveyed as Parcels 2 and 3 is hereby dedicated as and for a public street and the same is hereby named JAFFE COURT.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
