

RESOLUTION NO. 202223 MAR 23 1971

APPROVING MAP OF PENASQUITOS VILLAS UNIT NO. 3
SUBDIVISION AND ACCEPTING ON BEHALF OF THE CITY
OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS TOGETHER
WITH THE EASEMENT AS GRANTED ON THIS MAP WITHIN THIS
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by RICHARD T. STANDISH, Registered Civil Engineer, and entitled,
"PENASQUITOS VILLAS UNIT NO. 3 Being a subdivision of a portion
of Rancho Los Penasquitos, in the City of San Diego, County of
San Diego, State of California, according to the Map accompanying
the Patent to said Rancho recorded in the office of County Recorder
of San Diego County, in Book 2, Page 385 of Patents.", is made in
the manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council accepts on behalf
of The City of San Diego, a municipal corporation, any and all
abutters' rights of access in and to Carmel Mountain Road, adjacent
and contiguous to Lot 1, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on
behalf of The City of San Diego, a municipal corporation, the
easement for road purposes as granted and shown on said map, and
subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map as and for the act of the Council that said Council has approved said subdivision map and that those certain abutters' rights of access, together with the easement for road purposes as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
