

RESOLUTION NO. 202234 MAR 23 1971

WHEREAS, The City of San Diego is desirous of acquiring a blanket aqueduct easement affecting a portion of Section 26, Township 18 South, Range 2 West, San Bernardino Meridian; and

WHEREAS, California-American Water Company, a California corporation, is willing to convey said easements to the City in exchange for a deed from the City, conveying easements for waterline purposes affecting portions of Section 26, Township 18 South, Range 2 West, San Bernardino Meridian; and

WHEREAS, said exchange will allow the City to complete development and utilization of the Silverwing Park property; and

WHEREAS, the value of the property rights to be exchanged are equal, as determined by a staff appraiser, being the sum of \$500.00 each; and

WHEREAS, it is in the public interest that said exchange be made, and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, an easement deed, the form of which is on

file in the office of the City Clerk as Document No.

735343, conveying to CALIFORNIA-AMERICAN
WATER COMPANY, a California corporation, easements for
waterline purposes affecting portions of Section 26,
Township 18 South, Range 2 West, San Bernardino Meridian,
as more particularly described in said form of easement deed.

BE IT FURTHER RESOLVED, that the City Clerk of said
City be, and he is hereby authorized and directed to
deliver said deed to the Property Director of said City
for further handling.
