RESOLUTION APPROVING THE PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 201874, FOR THE IMPROVEMENT OF ALLEY LYING BETWEEN BLOCK 3, FIRST ADDITION TO OCEAN SPRAY TRACT AND PORTION OF LOT 5, PUEBLO LANDS SUBDIVISION LOT 1783, ALLEY, BLOCK 38, FAIRMOUNT ADDITION, ALLEY, BLOCK 48, TRACT 1368, RESUBDIVISION OF FAIRMOUNT ADDITION, AND ALLEY, BLOCK 26, NORMAL HEIGHTS.

WHEREAS, this City Council did on February 9, 1971, adopt Resolution of Intention No. 201874 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that (1) certain changes and modifications be made in the proposed work to be done in said Resolution of Intention, and (2) that said Resolution of Intention be amended by the deletion of the improvement of the ALLEY, BLOCK 26, NORMAL HEIGHTS; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the plans, drawings, typical cross-sections, profiles and specifications for the improvement of ALLEY LYING BETWEEN BLOCK 3, FIRST ADDITION TO OCEAN SPRAY TRACT AND PORTION OF LOT 5, PUEBLO

LANDS SUBDIVISION LOT 1783, ALLEY, BLOCK 38, FAIRMOUNT
ADDITION, ALLEY, BLOCK 48, TRACT 1368, RESUBDIVISION OF
FAIRMOUNT ADDITION, AND ALLEY, BLOCK 26, NORMAL HEIGHTS,
heretofore filed in the office of the City Clerk as Document
No. 734713 and approved by Resolution No. 201873 be, and the
same are amended to conform with City of San Diego Engineering
Department Drawing Nos. 14227-1-D through 14227-4-D, filed
in the office of the City Clerk as Document No. 735407,
and the same are hereby approved and adopted as the official
drawings, typical cross-sections, profiles and specifications
for said work and improvement.
