

RESOLUTION No. 202283

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that quitclaim deed of AVCO COMMUNITY DEVELOPERS, INC., a California Corporation, executed in favor of The City of San Diego, bearing date March 8, 1971, quitclaiming to said City the South Half of that certain parcel of land designated as "Camino del Reposo" lying between the Easterly line of El Paseo Grande and the Westerly line of Paseo Del Ocaso, in La Jolla Shores Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1913, filed in the Office of the Recorder of San Diego County June 3, 1926, as more particularly described in said quitclaim deed, as certified by the Property Director be, and the same is hereby approved.
