BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of DALE BUILDING COMPANY, executed in favor of The City of San Diego, bearing date January 28, 1971, conveying to said City an easement and right of way for street purposes through, over and across a portion of the Northeast Quarter of the Northeast Quarter of Section 35, Township 18 South, Range 2 West, San Bernardino Base and Meridian, according to United States Government Survey thereof, together with easements for sewer and drain purposes, as more particularly described in said deed, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named ATHEY AVENUE.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
