BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the County of San Diego for the transfer of said City's animal regulation functions to said County, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 735441.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City, an agreement with the County of San Diego, leasing to said County the animal regulation facilities which said City now has, under the terms and conditions set forth in the form of lease agreement on-file in the office of the City Clerk as Document No. 735442.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within the General Fund the sum of \$86,500 from Department 53.50, Unallocated Reserve, to Department 19.00, Animal Regulation, Non-Personal Expense and to expend said Animal Regulation, Non-Personal Expense funds for the above purposes.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer to the

San Diego County Tax Collector a proportional share of  
the animal regulation revenues collected by City for  
fiscal year 1971, under the terms and conditions set forth  
in Article I, section 7 of that form of Basic Animal  
Regulation Agreement on file in the office of the City  
Clerk as Document No. 735441.
