WHEREAS, the State of California has constructed State Highway 109 and Interstate 5 in the City of San Diego; and


WHEREAS, construction made no provision for a northerly connection to Interstate 5 from State Route 109; and

WHEREAS, a study of traffic flow has indicated that such connections are needed to provide more rapid and direct access to Interstate 5 from Ocean Beach and Point Loma, and to reduce through traffic in Mission Bay Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the State of California, Department of Public Works, Division of Highways is requested to construct connections to and from the north at the junction of Interstate 5 and State Route 109 in the City of San Diego at the earliest practicable date.
