RESOLUTION NO.

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA DECLARING THE BOUNDARIES OF ZONES FOR THE LEVY AND COLLECTION OF TAXES FOR A PORTION OF THE CITY NAMED "CITY OF SAN DIEGO PENASQUITOS SEWER DISTRICT" AND DIRECTING THE CITY CLERK TO FILE SAID BOUNDARIES WITH THE STATE BOARD OF EQUALIZATION AND WITH THE SAN DIEGO COUNTY ASSESSOR.

WHEREAS, on October 15, 1970, the Council of The City of San Diego adopted Resolution No. 201037 determining the boundaries of an improvement district to be named "City of San Diego Penasquitos Sewer District," and determining that in the opinion of the Council the taxable land within said district will be benefited by the acquisition, construction, completion and financing of certain improvements and determining that the public interest and necessity require the formation of such improvement district and the issuance of bonds which shall be obligations of and be issued on behalf of such improvement district and forming such improvement district named "City of San Diego Penasquitos Sewer District"; and

WHEREAS, on December 8, 1970 the City Clerk to comply with Government Code Sections 54900 et seq. notified the San Diego County Assessor and State Board of Equalization of the formation of the City of San Diego Penasquitos Sewer District; and

WHEREAS, on December 8, 1970 the City Clerk to comply with Government Code Sections 54900 et seq. filed a legal description of the boundaries and a map indicating the boundaries of said district with the San Diego County Assessor and the State Board of Equalization; and

WHEREAS, the taxable land within the improvement district should be taxed at differing rates consistent with the amount of benefit such taxable land derives from the acquisition, construction, completing and financing of works, improvements and facilities for the collection, treatment and disposal of sewage including interceptor and trunk sewers, pumping plants, appurtenances and appurtenant works within said district; and

when there is a creation of, or change in, the boundaries of a district or a zone thereof, the Council shall cause to be filed a statement of such creation or change with County Assessor and State Board of Equalization;

NOW, THEREFORE, the Council of The City of San Diego DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. That the exterior boundaries of the portion of said City which will be benefited by the CITY OF SAN DIEGO PENASQUITOS SEWER DISTRICT are as set forth on a map on file with the City Clerk as Document No. 733736 and are described in Exhibit "A" attached hereto.

Section 2. That the exterior boundaries of that zone within said district, hereby designated "Zone A," wherein the taxable property receives a full benefit from the improvements and facilities described in the above recitals are described in Exhibit "B" attached hereto.

Section 3. That the exterior boundaries of that zone within said district, hereby designated "Zone B," wherein the taxable property receives a partial benefit from the improvements and facilities described in the above recitals are described in Exhibit "C" attached hereto.

Section 4. That the City Clerk is by this resolution hereby authorized and directed to file with the San Diego County Assessor and the State Board of Equalization a certified copy of the map on file with the City Clerk as Document No. 735443 depicting said boundaries and a certified copy of this resolution and the exhibits attached hereto.
