BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with KODMUR TRANE SERVICE AGENCY, a franchised agent of TRANE COMPANY, for repairing and overhauling three reciprocating chillers at the San Diego Stadium for a total cost not to exceed \$4,675, and to maintain these chillers for a cost of \$4,925 for a period of one year and from year to year thereafter for four additional years unless sooner terminated, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 735455.
