

RESOLUTION No. 202325

Adopted on APR 1 1971

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 82.19 of the San Diego Municipal Code, the following streets in said City be, and they are hereby declared to be ONE-WAY STREETS:

ILEX AVENUE, eastbound, between Nineteenth Street (Saturn Boulevard) and Green Bay Street;

RIMBEY AVENUE, westbound, between Nineteenth Street (Saturn Boulevard) and Green Bay Street; and

GREEN BAY STREET, southbound, between Iris Avenue and Rimbey Avenue.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be, and the same are hereby authorized to be made on said streets, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
