BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with LOCH CRANE AND ASSOCIATES, architects, for architectural services in connection with the design and construction of Mountain View Community Center, Bay Bridge Community Center and Logan Avenue Recreation Facility, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 735513.

BE IT FURTHER RESOLVED, that the expenditure of \$43,500 is hereby authorized from Capital Outlay Fund 245 solely and exclusively for the purpose of providing funds for the architectural services described above and related costs.
