

RESOLUTION NO. 202354 APR 6 1971

WHEREAS, the Security National Bank of Kansas City, Kansas, has by affidavit stated that on August 7, 1969 they mailed Coupon No. 41 from Bonds Nos. 2156, 2157, 2158, 2159 and 2160, City of San Diego Water Works, Series A, 2% due 1978, to Bankers Trust Company, New York City, New York; and

WHEREAS, Bankers Trust Company has by affidavit on October 27, 1969, stated that the coupons were not received; and

WHEREAS, there is no cost to issue new bond coupons; and

WHEREAS, Section 53460 et seq. of the California Government Code permits a city to issue new coupons to replace lost coupons; and

WHEREAS, the Security National Bank has provided an Open Penalty Indemnity Bond for securities lost or destroyed dated December 29, 1969, issued by the St. Paul Fire and Marine Insurance Company of Minnesota holding the City harmless against any and all costs; and

WHEREAS, the Council of The City of San Diego is satisfied that Coupon No. 41 from City of San Diego Water Works, Series A, 2% Bonds Nos. 2156, 2157, 2158, 2159 and 2160 were lost or destroyed; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego
as follows:

That the City Treasurer be and he is hereby authorized
to issue five (5) new No. 41 coupons, dated August 7, 1969,
at \$10.00 each to replace those lost or destroyed.

BE IT FURTHER RESOLVED that the City Treasurer place
in his files the affidavits of the Security National Bank
of Kansas City, the Bankers Trust Company of New York,
and the bond written by the St. Paul Fire and Marine
Insurance Company.
