

RESOLUTION NO. 202359 APR 6 1971

BE IT RESOLVED, by the Council of The City of San Diego
as follows:

That the City Clerk is hereby directed to publish notice
of a public hearing to be held by the City Council in the
Council Chambers of The City of San Diego at 9:30 a.m. April 13,
1971, to determine and make findings upon the following
requirements of Section 70 of the Charter of The City of San
Diego pertaining to revision of salary and wage schedules:

(a) Has a significant change occurred in living
costs this fiscal year measured by the increase, if any,
in the Bureau of Labor Statistics cost of living index
between July 1, 1970 and January 1, 1971?

(b) If a significant change has occurred and as a
result thereof, are or are not salaries and wages fixed
for this fiscal year comparable to the level of other
salaries and wages of other public or private employments
for comparable services?

(c) If salaries and wages are not comparable, are
the best interests of the City not protected or in
jeopardy as a result thereof?

(d) Are necessary funds available?

(e) Has the Manager recommended a midyear revision
of salary and wage schedules?
